The entrance fee or any part thereof is non refundable once accepted as a member by the Executive.

I clearly understand that the Executive of Eagle Harbour Yacht Club reserves the right to refuse to consider this application and that any mis-statement or misrepresentation of fact made by me in this application shall be full and sufficient reason for the Executive of the Club to refuse to consider my application, or if accepted, to cancel my membership at any time without refund of any entrance fees or dues paid by me.

The rules of Eagle Harbour Yacht Club regarding allocation of mooring at the Eagle Harbour Yacht Basin are as follows:

If applications are received from members who are not already accommodated for mooring space at a time when all available space has been allocated, the Secretary shall cause a waiting list to be kept showing the names of the members applying for space and the space required by each. As space shall thereafter become available it shall be granted by the Club to the members appearing on the waiting list in the order of membership number and subject to Executive discretion.

The purpose of these rules is to assure that the members with the longest term of membership in the Club shall be given priority for space. The length of time a member has his name on the waiting list does not give him priority because, should a senior member require mooring, that member's name will be placed on the list ahead of all those who joined the Club subsequently.

The maximum dimensions of boats accepted into Eagle Harbour Yacht Club are not to exceed 38'0" in total length including all its appendages, nor have a beam greater than 12'0".

It is the wish of the Executive of Eagle Harbour Yacht Club that all persons joining the Club should understand these rules and should therefore not be disappointed at the length of time they may have to wait for mooring.

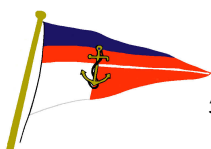
