Membership Year begins July 1 and ends June 30 each year. Junior Club dues are payable on or before July 1 each year. Membership is primarily for youths who wish to improve their sailing skills through active participation in individual and team sailing activities.

The Junior Club Program is available to children/youths between the age of 10 and 18 years. Junior Club Members who are older than 16 years of age may store a sailing Dinghy when space is available on the breakwater at EHYC for an additional fee.

A Junior Member has no seniority in the Society and can neither vote nor hold office, except in the affairs of the Junior Club. Junior Club entrance fees and annual dues shall be set by the EHYC Executive. Upon attaining the age of 19 years, a Junior Club Member may, if nominated, convert to Intermediate membership as detailed in By-law 2.1.3, unless exception is approved as per By-law 2.1.3(1). Should the Junior Member fail to convert membership at that time, they will cease to be a Member of the Club.





Photo of Dinghy
